

#### Tools Required for Installation

GlassCrafters recommends the following tools to properly and safely install your Illuminated Mirror.

A. Safety Glasses -should be worn at all times B. Tape Measure C. Level D. #2 Phillips Head Screw Driver E. Power Screw Driver



### IMPORTANT SAFETY INSTRUCTIONS

When using the Illuminated Mirrors, basic precautions should always be followed, including the following:

## BEFORE CLEANING ALWAYS SWITCH OFF THIS APPLIANCE.

**DANGER** - To reduce the risk of electric shock: 1. TURN POWER OFF at service panel before working on wiring or to unmount and disconnect the unit. 2. DO NOT SPRAY LIQUID CLEANERS on the Mirrors. For cleaning the mirror, we recommend using "ammonia free" Sprayway brand glass cleaner, which is available at a variety of retail outlets. 

#### **ELECTRICAL WIRING AND OUTLET LOCATION**

#### SWITCH OFF THE ELECTRICAL SUPPLY TO THE CIRCUIT BEFORE BEGINNING.

Unit is designed to be installed in a lighting circuit with a dimmer switch. Pre-wire as shown or run new wire from the new dimmer switch, which is dedicated to just this unit's operation. (120V), 14 Guage AWM).

The new outlet must be planned to the proper location behind the mirror so that the 90° plug from the unit installs easily without any tension on the cord. The extra cord should lay flat within the recess in the back of the unit.



#### **ELECTRICAL WIRING AND OUTLET LOCATION**

**STEP 1** — Measure for the Mirror location to determine the location of the new outlet. Mark left and right. The bottom of the mirror should be at least 6 inches above the surface of any vanity sink.

Back view of the units showing vertical center line. Always try to locate the outlet in the center of the unit placed above the marked base line of the unit as shown.





**STEP 2** — Run the new electric service from the dimmer switch to the location for the outlet (as shown on page 4). The new outlet must be planned to the proper location behind the mirror so that the 90° plug from the unit installs easily without any tension on the cord. The extra cord should lay flat within the recess in the back of the unit.


#### TABLE 1: BASE LINE OF THE "Z" BRACKET

FRAMELESS: above unit base 30" high — 26.75" 36: high — 32.75" Landscape format: 24" high — 20.75"

#### FRAMED: above unit base


30" high — 26.875" 36: high — 32.875" Landscape format: 24" high — 20.875"

Reminder: the Z bracket for the **Framed models** must use the shim supplied to provide the proper clearance for the Hanger to slide into the "Z" bracket.

#### **INSTALLATION OF THE MIRROR**

**STEP 3** — Confirm that installation marks are level. Inspect the wall for imperfections and determine that there are no water, drain or vent pipes or electrical wiring in the areas to be drilled for the wall "Z" bracket. Measure the proper location for the "Z" bracket from the base line mark in accord with the measurements in TABLE 1 on page 5.


Affix the Shim as supplied **(for Framed Models)**. Hold the "Z" bracket on the wall with the level and mark the holes. Wear eye protection, drill the required holes using a

masonry bit for tile. Install the Wall anchors. Screw into place with the screws supplied.

Note: the wall anchors and scews are engineered to hold the weight of the units.


DO NOT SUBSITUTE OTHER PARTS.


Section view showing the "Z" Bracket as used in the **Frameless** and the **Framed** Models.


The extra thickness of the Frame requires the Shim to offset the "Z" Bracket to engage the Hanger that is factory installed inside the Frame.



#### **INSTALLATION OF THE MIRROR**

**STEP 4** — Hold the Mirror in the proper orientation and rest the top against the wall. \*(Note for safety it is suggested that one person hold the mirror while the other reaches behind and plugs in the unit. Angle it as close to the wall as needed so that the cord is not under tension and you can easily plug it into the new outlet. Feed the excess wire back into the shallow space within the back of the mirror while moving the mirror flush to the wall just above the "Z" bracket. Slide the mirror down to engage the Hanger in the "Z" bracket. Adjust the mirror position for left to right.





#### STEP 5 - Turn the electrical circuit on.

Test the light and defogger unit using the dimmer switch.

- Be sure the unit is off after each use.
- Do not leave on for prolonged periods.
- Never cover the mirror.
- $\cdot$  Clean with a soft dry cloth only when the unit is turned off.

These claims must be filed with your dealer or professional installer and forwarded in writing to GlassCrafters within three years of the delivery date to the end user of the product. GlassCrafters shall not be responsible for any installation or removal costs. This warranty does not apply to the following, chemical or natural corrosion of the mirror. The use of abrasive cleaners or cleaners containing ammonia will cause chemical damage to the mirror, voiding this warranty.

The GlassCrafters' warranty does not cover product that is damaged in shipping, accidents in handling during installation or if the reported defects are a result of faulty installation, abuse, misuse, abnormal wear, poor maintenance, accident or repairs by service personnel other than the original professional installer as authorized by GlassCrafters. After the three

year period GlassCrafters shall not have any further obligation, expressed or implied including merchantability under the Limited Warranty.

GlassCrafters shall not have any liability for any consequential damages stemming from or in connection with the use per performance of this product. Prevailing state law on the limits of the implied warranty will apply.
